Letter from the Chairperson



t is again that time of the year when we get the chance to share our progress with our partners. I am delighted to report that we have much

to celebrate, but of course many challenges remain.

This year, after a long and arduous process, we finally received school recognition from the office of Director, Elementary Education, Haryana. This means that Vishwas is now an inclusive Middle School and will be adding three new classes (6th, 7th and 8th) in the coming academic year.

We have spent the last two years in preparing an Inclusion Kit, and I am pleased to report that this year we were able to present this to an audience of representatives from the office of Director, School Education, Haryana. These included school teachers and senior functionaries, and together we were able to address larger issues as we prepare to launch the kit.

Our application for 100% tax exemption for our donors under section 35 AC of the Income Tax Act was also successful, with validity through to May 15, 2016. Not only this, we are now listed with Give

India Foundation as an NGO entitled to get support from its donors.

In keeping with our strong emphasis on the rights of the persons with disabilities, we were in the forefront of the disability rights movement actively campaigning for the passage of an improved disability bill. Our efforts will continue to bring it to fruition.

Our Community Based Programme in Sohna block is close to completion, with only a few villages remaining. Once this is done, we will work to expand to other blocks. In collaboration with the office of Director School Education, Haryana we have also initiated the process of setting up a helpline for children with special needs. We hope to have this operational in 2015.

Last but not the least, Vishwas organized its first Annual Sports Day on the school premises This inclusive event proved to be a spectacular success, with both children and parents having a day to remember.

We still face huge challenges as we move forward, expand and improve our capabilities. Your support will be crucial to overcoming these, and I hope that we can continue to count on your generosity.

Vishwas Vidyalaya

his year saw Vishwas Vidyalaya receive official recognition to run as an elementary school (Class 1-8) from the Directorate of Education. Subsequently the school initiated admissions to Class 6-8. The Vidyalaya also formally reconstituted its school Management Committee (MC) to oversee the functioning of the school. The list of members of the MC was formally approved by the Board of Directors of Vishwas and later approved by the Department of School Education, Haryana. The Managing Committee has met twice after it came into existence and has discussed matters of importance for the smooth functioning of Vidyalaya. Details of the Management Committee members are provided in Annexure II.



Student enrollment

VISHWAS Vidyalaya continues in its endeavor to provide inclusive quality and meaningful education to all its students. In accordance with the Right to Free and Compulsory Education Act, 2009 and Vishwas' own practices, the teacher student ratio stands at 1:30. Nearly 85 percent of our students come from the economically backward sections of society and the Vidyalaya has 47 Childern with Special Needs (CWSN) who currently attend school. These include children with intellectual impairment, cerebral palsy, vision impairment and hearing impairment.



Vishwas Vidyalaya has maintained its student strength despite the fact that student retention has been a constant challenge. Most of our students come from impoverished migratory populations, moving with their families depending on their work opportunities. Many also return to their villages with their parents during the session or depending on work availability. The student strength at the school at the end of the academic year stands at 175 (63 girls and 112 boys)

Academic performance

THE year saw us consolidating and strengthening our initiatives on inclusive classroom transaction practices as well as continuing with the development of teaching learning material and individual lesson plans to meet with the class and individual needs of all our students. Where needed the classes were also reorganized to accommodate the learning needs of the students. The learning experiences and good practices from our work have been used to develop the Inclusion kit.

The school used National Council for Education, Research and Training (NCERT) textbooks for Classes II-V and the Sarv Shiksha Abhiyan(SSA) books as reference material. In-house workbooks designed to accommodate the needs of every child in the class were also provided to children of Classes Nursery and I.

Besides academic inputs, children with special needs were provided with individual need based speech and physical therapy. One of our students



from Class V was provided with a specially modified wheelchair for her mobility and to ensure postural change at regular intervals. Children with special needs have also been given individual sessions by our volunteers to maintain the pace of learning in the class. Many of our students are first generation learners and the Vidyalaya has ensured individual support wherever necessary.

At Vishwas Vidyalaya, students are provided with midday meal on all working days. Students look forward to meals provided by International Society for Krishna Conscience (ISKCON) who also provide to all the government schools of Gurgaon, and these are healthy and delicious too.

Examinations were held at Vidyalaya in the month of July, September, December 2013 and March 2014. Test material developed enabled all children to appear in the examination in accordance with their levels and abilities. Our students' performance in academics has been consistent meeting with the age, ability and grade standards. 17 of the 29 students of Class V have scored an overall Grade 'A' in the examination and will be joining the middle school in the next academic session.

MUSIC and dance sessions are held regularly for the students and this year also saw the formation of a student choir group and the school constantly reverberates with the sound of music! We hope to have our group participate in inter school events soon.

The school library is now subscribing to the Navbharat Times (Hindi) and Chakmak magazine to inculcate the reading habit in our students and improve their general awareness. Reading, recitation and creative writing are regular classroom activities.

Keeping abreast with technology

FOURTEEN students of Vishwas Vidyalaya who were enrolled for the basic computer certificate course at the NIIT Foundation gave their exams this year and were also awarded with their certificates.

THE in-house functions organized through the year provided our students the opportunity to increase their knowledge and showcase their creative skills. All religious festivals and National Days (Republic, Independence Day and Gandhi Jayanti) were celebrated by children with great excitement and energy. During Diwali, the older students put up a puppet show for the rest of the school on the harmful effects of crackers. Teachers' Day was celebrated with a lot of excitement on September 5.The students of Class V made personalized cards with beautiful messages for all the staff members. Teachers also planned a surprise dance performance which was hugely appreciated by the students.

Vishwas - Adult Programme

he 'Vishwas Welfare Haat' makes second hand goods available at nominal prices to our parents and the neighboring community. The proceeds from this venture were used to provide meaningful employment to a person with visual impairment. The activity also enabled our adult trainees to practice household skills like sorting, washing and ironing along with the basics of retail trade.

The young adults regularly collected durries and dusters from all the classrooms for washing. As part of their training in social skills, the group was involved in serving water at Vishwas. This activity provided them with an opportunity to independently interact with the entire staff thereby increasing their confidence level. The children and the staff at Vishwas Vidyalaya look forward to the different snacks prepared and sold by the trainees every day. The tuck shop has now gone beyond self sustainability and has for the first time made a small profit this year that they used to buy utensils.

Our young adults continue to be engaged in their regular practice of making of envelopes and painting and decorating of 'Diyas' around Diwali. They also participate in yoga and music sessions that are enjoyed thoroughly. Their participation in the First Annual Sports Day of the school in the team events was another high point for them.

NIIT foundation CAREER DEVELOPMENT CENTRE (CDC): A mass awareness campaign was undertaken by VISHWAS and the NIIT foundation to enroll persons with disabilities for their skill enhancement programme. Under the programme



seven young adults with disabilities were trained and later supported in finding placements. Trainings were provided in i) Personality Development, ii) Basic IT for beginners, iii) Social Networking and iv) Show Room Retail







Vishwas - Community based Programme





he community plays a crucial role in ensuring inclusion and equal opportunities for 'ALL'. Our Community Based Programme, this year reached 43 more villages bringing the total number of villages to 68 and covering the entire urban area of Sohna Block. Focus for the Vishwas-Community Based Programme for the financial year 2013-2014 was:

- Maximize the coverage of persons and children with disabilities.
- Strengthen networking with the government administrative setup.
- Establish linkages with the existing grass root service delivery agencies
- Sensitize key stakeholders in service delivery in the villages towards children and persons with disabilities

HIGHLIGHTS OF THE YEAR

Health

- 43 screenings were done to identify at-risk children during the Village and Health Nutrition (VHN) days in collaboration with the Auxiliary Nursing Midwife (ANM), Accredited Social Health Activists (ASHA) and Anganwadi workers of the villages covering 410 children in the age group of 0-6 years.
- ■90 ASHA were trained in identifying children at risk (0-3 years) for congenital anomalies/defects, development delays, disorders and deficiencies under the new module. This was part of their in-service training following a representation made jointly to the Deputy Commissioner and Chief Medical Officer, District Hospital, Gurgaon. The entire block of Sohna and part of Gurgaon block was covered.
- ■91 Anganwadi workers in Sohna block were sensitized during their regular monthly meetings to help them understand their roles in

the identification of children at risk (0-3 years) and include children with development delays (3-6 years) in their early childhood care and development (ECCD) programmes



Education

- Coordinated with Integrated Education for Disabled-IED Principal cum Block Resource Coordinator of Sohna Block for enrollment of children with disabilities in the age of 6-14 years in government schools. Provided the resource teachers with data and contact details of 29 out of school children with special needs(CWSN) in the villages covered by Vishwas
- Participated actively in the 'Jagriti Camp' organized at the Block Resource Centre, Sohna. The camp was organized as a platform to create awareness, showcase skills of children with disabilities and to facilitate interaction with parents of children with disabilities.



Community Involvement and Sensitization





- During the year 2013-14, Gram Sabhas were very actively organized in the villages and video recorded for purposes of accountability. We participated in those meetings and ensured that persons with disabilities registered as service users with the program were present and raised relevant concerns as well.
- The 'Prashasan Apke Dwar' (Administration at your Doorsteps) was an initiative taken by the district administration. The Vishwas group spread the information among persons with disabilities to ensure their participation and inclusion of their concerns in regular development programmes. Disability certificates were also made during this initiative
- We also coordinated with the District Development and Panchayat Officer (DDPO) along with the Block Development and Panchayat Officer (BDPO) to conduct sensitization of all the 38 Sarpanchs of the Sohna block.









Direct Intervention

- Conducted hands on training of the field workers on interventions for children and persons with disabilities
- Individual parent training sessions were conducted with the field workers to make them understand the need for regular therapy, education and training for children with disabilities
- Persons with disabilities covered in the new villages were informed of the entire process of getting the disability certificates

STORY OF CHANGE



Armaan s/o Tasleem, was identified with cleft palate at the age of 11months during a screening on Village Health and Nutrition Day at Kuliyaka. The child's parents were referred by the Vishwas group to Smile foundation for surgical intervention. The deformity also affected his food intake and Armaan fed only on breast milk till then was also severely malnourished. The parents acted swiftly and his surgery was done at Smile foundation. Today, with his ability to chew, eat and drink improved significantly, Armaan is a healthy and happy child

Vishwas - Research and Training



Preview of the Inclusion Kit

he first draft of our Inclusion Kit which we began in 2011 in partnership with the Haryana State Education department and Bharti Foundation was ready to be shared with teachers and other people in the Education department. This draft was presented by Vishwas to the School Education Department at Panchkula on 4th March 2014. The group included representatives from the Education Department, State Resource Groups, Block Resource teachers and general teachers. The session was quite interactive and the group gave some very useful

suggestions. Many of these suggestions have been incorporated in the Kit that is expected to be launched formally in the next financial year. The material was developed through a participatory process and included the suggestions and recommendations from the participants at the Panchkula workshop. The final kit will contain a manual, video clips, flashcards, posters and worksheets for teachers (resource and general) to be used in the classroom for all children incuding children with special needs (CWSN)





Vishwas Tele- Helpline for School Education- Haryana





VISHWAS is collaborating with Director, School Education, Haryana to establish a tele-helpline to provide information and guidance to facilitate Inclusive Education for children with special needs in the age group of 6-14 years under the Right of Children to Free and Compulsory Education (RTE) Act, 2009. Under the project, a resource directory of the available resources and entitlements for all children in the age group of 6-14 years would be compiled. It would provide all the information and guidance on entitlements/ schemes/resources related to Children with Special needs and their families. A helpline would also provide telephonic consultative support to parents, children and teachers to establish linkages with service providers, NGOs and other stakeholders for Inclusive Education for Children with Special Needs. Data and information is being collected and the helpline is expected to be functional in the coming year.





Under the project, all 21 districts of Haryana will be visited to gather and collate information. The Vishwas team has so far completed visiting 8 districts and met with all the concerned officials in different districts. These included the District Education Officers, District Project Coordinators, District Child Welfare Officers, District Social Welfare Officers, District Child Protection officers, IED Principals cum Block Resource Coordinators, Block resource teachers, Secretary, Red Cross Societies and NGOs working in education of children with special needs. The process adopted was completely participatory, in which the concept was shared at each district meeting and suggestions were sought from the participants.

In service training



VISHWAS strives to provide comprehensive and varied opportunities for in-service training of its staff. This year staff attended training programmes ranging from transfer skills to teaching Hindi and learning sign language. A list of in-service training is provided in Annexure IV

Vishwas participated at the preparatory meeting under the Chairmanship of State Commission of Protection of Child Rights, Haryana and Public hearing of Haryana on RTE organized by National Commission for protection of child rights, at Faridabad and raised relevant issues.



Advocacy for the Disability Bill





VISHWAS was an active State player during the drafting of the 'New Bill for Persons with Disabilities in 2010-11. However the Bill has still not been introduced in Parliament. Vishwas was part of the core group along with members of the Disabled Rights Group (DRG) and the National Platform for the Rights of the Disabled (NPRD) that met with top leaders of national parties to push for the introduction and passage of the Bill. Vishwas also participated in a protest march at India Gate, New Delhi. A signature campaign was also undertaken with the stakeholders of the

Community Based Programme at Sohna and parents of students of Vishwas Vidyalaya and the copies of the same were sent to Sonia Gandhi, Rahul Gandhi, Arun Jaitley and Sushma Swaraj in support of the bill.


