As we had shared with you last year, almost one fifth of our families/students didn't come back. That is always the downside with long disruption of the kind Covid caused. But very quickly many more new students came in and we were back to our full strength. In addition to our regular work, we also made much needed home visits to our students with special needs. This helped our staff to understand their home conditions and implement the plans better in consultation with their families.

More than ever before we all wanted to add new things to make up for the losses of two terrible years. Our Disability Resource Center was upgraded with some new equipment and colourful floor and furniture. Students loved the lively atmosphere and are enjoying their sessions. Communities opened up and our team was back with them right away. Nothing can replace going personally to be with your beneficiaries and their families. Many challenges like lack of proper documents, resources and accessibility still remain. Our team is constantly working to fill these gaps. To make our work more effective we visited many other organisations working in similar areas in Gurugram. Going ahead, this will help in collaborations and referrals.

For our young adults with special needs, it was very important to get back to normal life where they could interact with the rest of the world. It was not that easy to explain the concepts virtually and implement many other important steps. A foundation was laid to create new opportunities for their independent living. Necessary trainings were added to make them ready for various job opportunities. Meanwhile our efforts are on to identify open minded corporates to expand job opportunities for them. We are grateful to all our supporters who stood by us in those difficult times.

Let's move ahead with hope and new dreams.

# VISHWAS VIDYALAYA

### eLearning

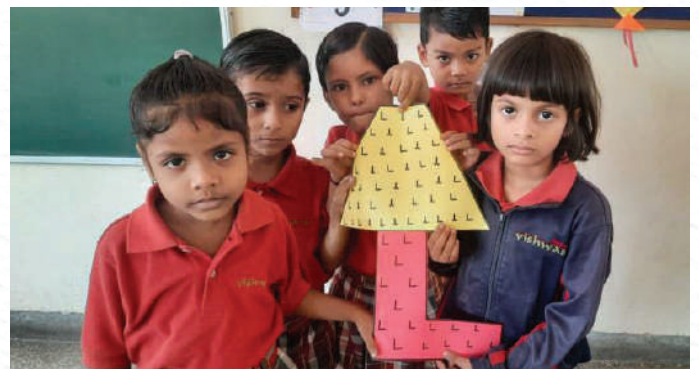
The use of digital platforms for learning is changing our education system. Students of grade VI to VIII have been learning maths and science through Tablets on a regular basis.

# SUCCESS STORIES

## LAKSHYA



Lakshya is a student of grade III and is a very keen learner. She is a single parent child as she has lost her father and is being brought up single handedly by her mother. Her mother is working with a small private company. Mother and daughter live in a small rented accommodation. Lakshya was an extremely shy, introvert girl initially and didn't mingle in the class. She didn't want to participate in any of the activities. With a supportive classroom atmosphere, she is opening up and has started taking part in all the activities. She is keen to try new things. Due to cerebral palsy, she has postural issues.

Regular therapy provided at VISHWAS is helping in postural improvement as well as her hand functioning. As a result, her handwriting is improving. She has started enjoying school now.

## KYRA



Kyra is a student of grade I. She has Autism and was a very hyper child when she joined Vishwas Vidyalaya, a year ago. She was extremely restless and would refuse to sit down in class, spit around, pull her own hair. She made no eye contact, listen to any instructions and didn't even eat her lunch. The perseverance of teachers and a friendly classroom atmosphere helped to bring about visible changes in her. She is happy sitting in the class, eating food with friends, has stopped spitting and pulling her hair now. She has started taking part in group activities and celebrations.

Due to these social changes, a hidden talent was also discovered. She can write words in both directions. She tries to communicate with her friends. Her mother was very vocal in her joy, on seeing Kyra dance on stage during Annual Day celebrations.



# VISHWAS SKILL DEVELOPMENT AND TRAINING PROGRAMME

This programme caters to young adults and adults with disabilities (PwDs) in the age group 14-25 years. Its aim is to provide life skills for independent living and skill development for employment opportunities, keeping in mind their ability and challenges. During the academic year, 25 trainees were enrolled in the programme. The disabilities range from Cerebral palsy, Autism Spectrum Disorder, Intellectual disability, Hearing Impairment and Multiple disabilities.

## MAIN ACTIVITIES

### Activities of daily living (ADL)

Many PwDs depend on others for their day to day life tasks such as feeding, bathing, toilet, grooming etc. ADL training is the core area of our work. This year too, several young boys and girls were trained in ADLs through regular group sessions and parental trainings. We also provide parental training to manage menstruation cycle as well as their puberty related issues.



### Sports and Physical Activity

A considerable amount of time was spent in engaging them in yoga, other outdoor activities, as well as indoor ones. This is helping in their overall well-being. Due to regular training in sports, some of them also got opportunity to participate in state and national level events held by SOB (Special Olympics Bharat) and also won laurels.



### Learning money concepts

Canteen was reopened after Covid with the objective of familiarizing them with the concept of handling money, recognizing currency and dealing with customers. Under the supervision of their teacher and helper didi, some of the trainees are showing signs of capacity to handle business transactions. They sell chips, candies and beverages to Vidyalaya students during lunch break. At present, 5 of them are being trained in the canteen.



## Preparation for Hospitality sector

As in the past, after gauging their capability, some of them are being trained in some aspects of hospitality. This includes- dusting, cleaning utensils, arranging cutlery, folding bedsheets, changing pillow covers, arranging kitchen shelves, loading washing machine, drying clothes, folding them etc. However for structured formal training and hands on learning experience there is a requirement of setting up a training simulator, which is in process.



## Computer Literacy

Two of our trainees have keen interest in computers. They are being provided exclusive coaching to impart computer skills. Apart from them all the others also are learning basics to help familiarize them with computer use.



## Recreation

There were many other activities like art and craft, beading, envelope making and solving puzzles. The purpose of such activities is to keep them engaged in a meaningful manner. During the festive season students engaged in painting earthen lamps and Lakshmi-Ganesh. These were sold in Diwali stalls.



## Loom

Students are enjoying working with threads and wool on the loom. They are creating beautiful table mats and runners. Being not only a calming and therapeutic engagement, it is also fruitful for improving fine motor skills and attention span.



## CELEBRATIONS

The students participated in all festival and event celebrations along with the Vidyalaya students.



## NEW INITIATIVES

It is always desirable to try new skills with the trainees. This helps to add variety and also understand what may work/ not work. This year we tried our hands at candle making and customized printing on ceramic mug. Our students made sketches of endangered animal species. These were then printed on ceramic mugs.

## HOME VISITS

Special educators visited homes of some trainees who were irregular or had other issues. And this indeed proved helpful in planning their training and to understand the environment at their home, lifestyle, family structure and financial challenges.

## ACHIEVEMENTS

Out of the 12 trainees who had enrolled for National Institute of Open Schooling (NIOS), 5 of them successfully cleared their grade X exams.

On 9th September 2022, job fair for PwDs was organized by VISHWAS. Companies like DLF, E&Y, Concentrix and Startek participated. Trainees Devashu, Kshitiz, Priya, Jatin Kundu, Shivam Madaan and Suman participated in it. It gave them an understanding of how job interviews are conducted. It also helped to understand the expectations of employers.

## CHALLENGES

Disability is still an area that requires huge attention, willingness and support at all levels- government, corporates/ companies, community and family.

### • Lack of awareness

A significant number of parents and caregivers lack basic knowledge of realistic expectations and age appropriate goal planning for the child. Owing to this, it becomes extremely tough to train them for a vocation

### • Attitude of Companies

Following the RPwD Act, 2016, government and private companies are liable to have Disability Inclusive workforce. However, there are hardly any modifications, adaptations at their offices or change in attitude to accommodate PwDs. Also due to unrealistic expectations, job fairs become a formality

### • Dependence

Many PwDs are dependent on family members for commuting to work. This is not sustainable. Hence placement rate is small and drop-out rate high.



# SUCCESS STORIES

## RAUNAK



Raunak is a confident 16-year-old girl, facing the challenges of right-side hemiplegia, a form of cerebral palsy. Regular schools didn't provide a conducive atmosphere for her to learn due to her struggling performance. Hence, she had to discontinue schooling. She lost all her confidence and was very dejected. She had been receiving support from the Disability Resource Center of Vishwas before joining the Skill development and Training Programme.

Due to the caring and empathetic intervention at Vishwas, she is a very happy and confident girl now. She is acquiring a range of practical skills, including effective communication, hospitality, and money concepts. She enjoys participating in all the extra-curricular activities, especially dance.

## TASHU



Tashu is a very talented girl with hearing and speech impairment. She was a part of the Vidyalaya upto grade VIII and then joined the skill development group. As part of this group, she is receiving training in loom and hospitality. At Vishwas, her keenness and enthusiasm are soaring to new heights because of the opportunities provided. She is an all-rounder and doesn't miss an opportunity to participate in dance, art & craft and sports. She received first prize in group dance at the event, ROSHNI, held by Concern India Foundation. She won silver medal in Badminton in Unified Sports.

She has cleared grade X through NIOS and is preparing for XII now. She has a very supportive family. She is enjoying working on the loom and creating products.



# VISHWAS COMMUNITY BASED PROGRAMME (CBP)

VISHWAS Community based Programme aims to promote “Disability and Inclusive Development” through rights-based approach. Through this programme we are creating an enabling environment by community sensitization, raising awareness, facilitating Persons with Disabilities (PwDs) to avail their rights and entitlements, empowering them to participate in decision making, sensitizing relevant stakeholders in the community to accept diversity and promote inclusive practices. Our focus has been on identifying and initiating contact with PwDs, striving to link them with existing resources, availing rights and entitlements.

We have been actively working in the following areas- Wazirabad, Kanhai, Jharsa, Islampur, Tigra, Samaspur, ArdeeCity, Darbaripur, Jalvihar, Darbaripur, Jal Vihar. This year we have expanded our reach to Ghata, Tikri, Badshahpur, Khandsa, Dhankot, Chandu, Gadoli Khurd, Gadoli Kalan, Begampur Khatola, slums of sector- 56 & sector 58. This makes it a total of 22 localities.

## OUR FOCUS THIS YEAR

- To ensure that the identified children and persons with disabilities get the required intervention and to link them with the best possible available resources/services within the immediate community
- Connecting PwDs to jobs based on their skills, education, experience
- To create accessible and inclusive workplaces by employers for PwDs.
- Creating awareness about their rights and entitlements and disseminate information about disability welfare schemes in collaboration with government and non-government stakeholders
- To improve the overall knowledge, attitude and practice of the community on disability inclusion & awareness

## CHALLENGES

- PwDs with high support needs generally lack documents i.e Birth certificate, Adhar card, Family Id, due to which it is difficult to connect them with welfare schemes
- Awareness among parents and caregivers regarding identification & intervention of disability is negligible. Hence diagnosis and rehabilitation do not occur at the appropriate time
- Lack of resources and accessibility (health, education, employment & vocational skills, roads & buildings ) in rural areas makes it difficult for the beneficiaries to avail services on time.
- PwDs are still seen with pity or ignored. This adds to loss of their dignity and self-respect

## ACHIEVEMENTS

- Follow up of 345 beneficiaries done through telephonic conversation and direct home visits
- Provided need-based therapy & counselling sessions to 110 PwDs
- 75 new beneficiaries identified for early intervention and assessment of developmental disorders
- UDID application has been submitted for 89 beneficiaries
- Niramaya health insurance policy renewed for 14 beneficiaries and one new application submitted
- Aids/ appliance provided to 23 beneficiaries.
- 51 meetings with government departments and NGOs held to coordinate with them to promote disability inclusion and awareness
- Conducted 97 meetings and follow-up of anganwadi & ASHA workers
- Referred 3 children to District Early Intervention Centre (DEIC) Civil Hospital, Gurugram
- 44 PwDs participated in district level awareness workshop on RPwD ACT at VISHWAS
- In the district level job fair for PwDs conducted at VISHWAS, 37 PwDs and 5 employers (Startek, Concentix , EY , DLF, Employment department ) participated. 7 candidates got selected for jobs
- 6 beneficiaries benefitted from aids / appliances camp held at VISHWAS

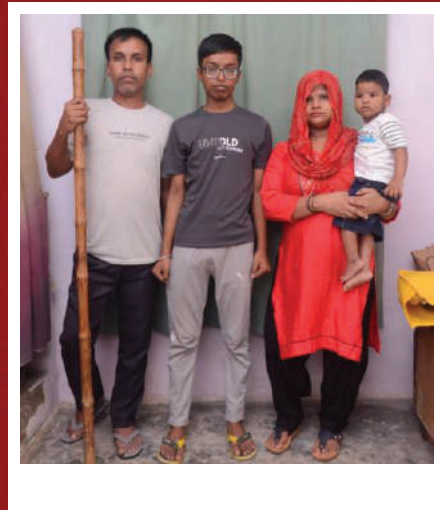
## AYUSHMAN



Our CBP team came across Ayushman, a 6 years old child with cerebral palsy (CP) during their visit to Dhankot village. His mother shared that her financial condition was very bad as she had separated from her abusive husband. She could not afford any rehabilitative service for her child. She herself is diabetic and under a lot of mental stress. They were connected with VISHWAS Disability Resource Centre where need based intervention, guidance and counselling was provided for his appropriate care and development.

The CBP team facilitated application of his UDID card, Disability Certificate. Our team approached “Bringing Smiles”, Ngo and with their help he has been provided a wheelchair and also receiving financial help of Rs.5000 monthly. He is enrolled in VISHWAS Vidyalaya and enjoying school life along with therapy. His mother is very happy with the positive changes and a purpose in their life now.

## DHARAMVIR



Dharamvir a resident of Badshahpur, Gurgaon is 38 yrs old and has locomotor disability since birth. His wife and both his children also have disability. During field visit, our CBP team met him and came to know about their miserable condition. He runs a small tailoring shop from home which is not enough to meet their daily expenses. The CBP team provided counseling and facilitated UDID and disability certificate of Dharmveer and his wife.

This has helped them to enroll for disability pension of Rs.2750 monthly which will improve their financial condition. His daughter is receiving early intervention and therapy from VISHWAS Disability Resource Center and his son was referred to AIIMS hospital for eye treatment.

Dharamvir is elated and thankful with the support and guidance received from the CBP team.



# VISHWAS RESEARCH & TRAINING PROGRAMME

Disability Resource Centre (DRC) under this programme is an initiative to provide one point solution for disability inclusion related issues at VISHWAS. In addition, our team is also involved in building the capacity of other programmes by providing information, education and technical support in accommodating persons with disabilities (PwDs) in a meaningful manner.



## MAIN ACTIVITIES

### Assessment and follow up of beneficiaries

This year, we registered 60 new children/adults with disability (in addition to existing 27 in the programme). Based on the initial screening and assessment, individual plan of action was prepared by the team and follow up sessions were taken.

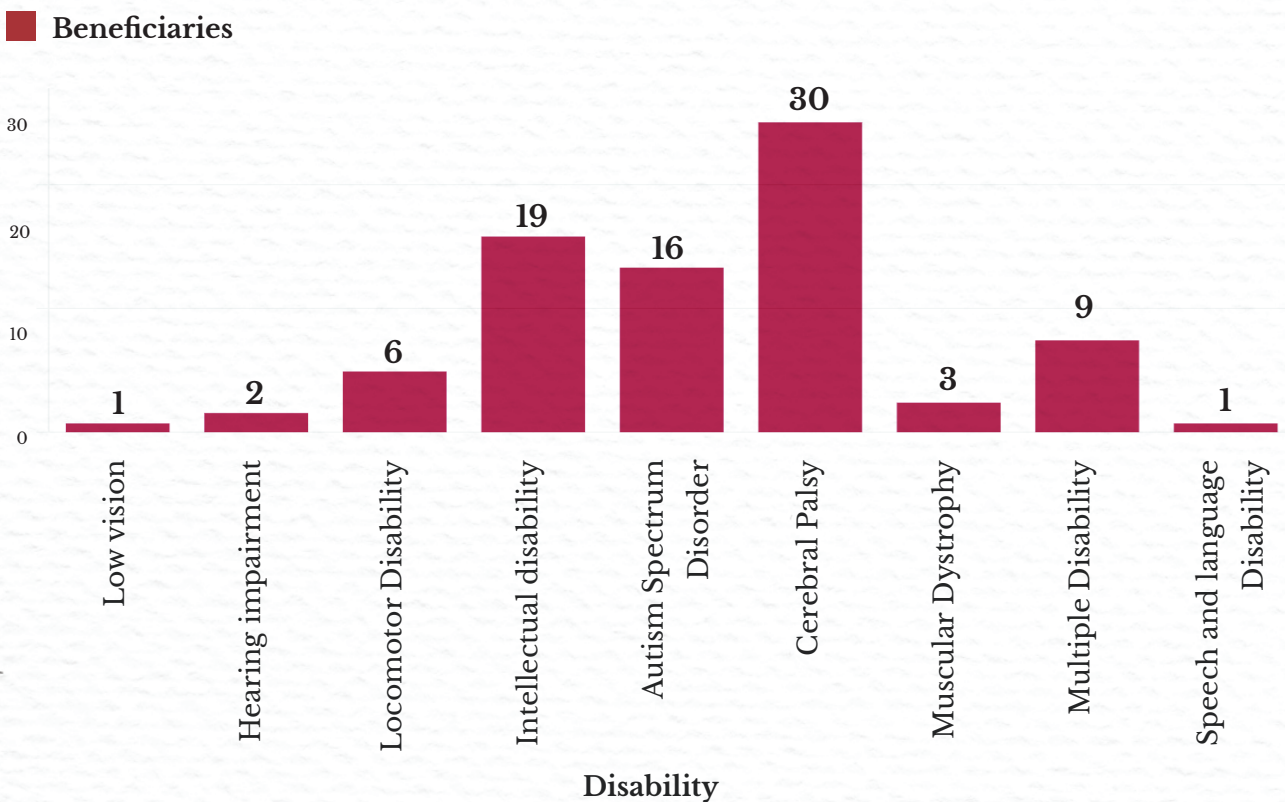
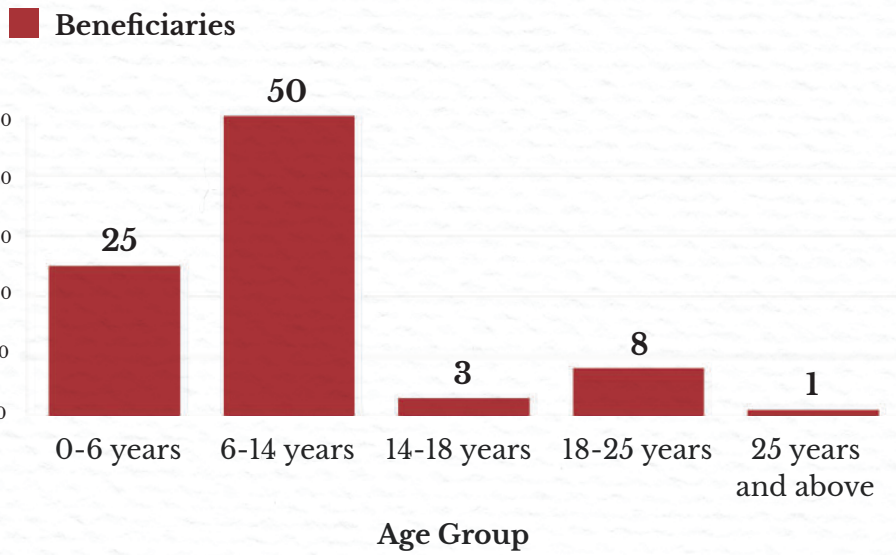

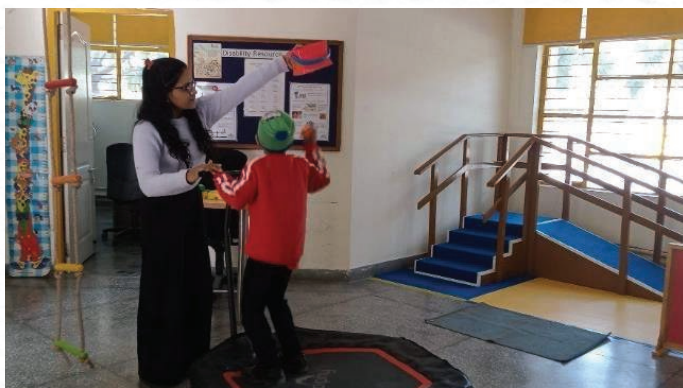

## RENOVATED RESOURCE CENTRE

This year, we renovated our DRC and turned it into a more structured and vibrant space for children. They are loving the colourful and lively resource room. In addition, separate cubicles for physiotherapy, occupational therapy, speech and auditory therapy as well as a play area have been made. Students are also benefiting from group hearing aid, introduced this year.



### Capacity building

Another key role of our programme is conducting training sessions for staff of VISHWAS. The objective of these trainings is to enhance the skillset of the staff, to make the classrooms more inclusive and learning efficient. Trainings were conducted for various programmes of VISHWAS.

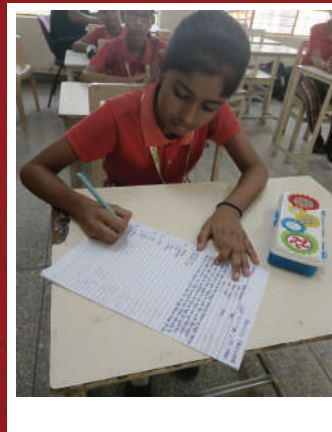
## HIMANSHU



Himanshu is a seven years old boy who is hyperactive and his mother has OCD (Obsessive compulsion disorder). During his visits to the DRC, his father shared that he is the sole caregiver for his child and wife and many a times due to frustration he would lock up Himanshu. To cope with his responsibility, he has taken up night shift job as a driver. With an integrative approach, his mother was counselled for taking treatment and medication seriously so that she could be beside her children.

Certain activities were suggested for Himanshu for his behavioural improvement. Disability certificate of Himanshu was also facilitated. He was granted admission to the Vidyalaya in grade I and has been attending school regularly. His father is happy that he is able to get some “me time” now and is able to take better care of his family.

## PALLAVI



Pallavi is a regular student of grade V of Vishwas Vidyalaya. Suddenly, her teachers and class mates started noticing that Pallavi was not responding to their verbal instructions and required repeated ones. A meeting was held with her parents and it came out that they were also facing similar issues with Pallavi at home and also that her mother and brother had congenital hearing loss. She was referred for immediate medical intervention. With intervention of Vishwas, her audiometry and other tests were conducted free of cost by a renowned ENT specialist. She was prescribed medicines and her brother was given a hearing aid. Doctor also mentioned that if it would not have been treated on time, it may have resulted in permanent hearing loss. This explains very well the criticality of early intervention. Vishwas also supported parents to get appointment for follow up and acclimatization of the hearing aid. Pallavi and her brother have overcome their auditory issues and credited VISHWAS for their support.
